- ♣ MIVIA learning will be providing teaching lessons under the following conditions:
- * I parent/carer understand that I am responsible for payment of all fees, when they are due. I also understand that the fees is paid four/five weeks prior to lessons. Class fees are not refundable or transferable. All fees should be paid monthly in advance. Fees are fixed.
- * I parent/carer understand that I must inform 24 hours prior to any absence in lessons.
- * I parent/carer understand that I am responsible for my child's absence in lessons. 3 consecutive weeks of absence will result in your child's space becoming allotted to another child instead.
- * I parent/carer understand that I must pay for all classes including those that my child is absent as resources and extra help will be provided to make up for the knowledge missed during those lessons.
- * I parent /carer understand that I am responsible for the proper device, required resources and tranquil environment during the class time to ensure that my child learns to his/her best ability.
- * I parent/carer understand that I am responsible for my child's punctuality in all lessons including face to face and online lessons.
- * I parent/carer understand that I am responsible for all materials, support and required resources that my child may need for homework and extra work outside of lessons to ensure gradual improvement in education.
- *I parent/carer understand that I am responsible for communication between the teacher and child out of lesson times to ensure instructions are delivered to my child about lessons.
